Terms and conditions:

- 1. The quotes are invited in TWO BIDS system, Technical and Financial in two sealed envelopes by 25th May, 2012. The technical bid will be opened first. The financial bid will be opened of those bidders who will qualify technically.
- 2. The quoted price shall be treated as inclusive of delivery charges but taxes, if any, must be indicated separately.
- 3. The bidder shall provide only one sample of each item, as per specimen attached, along with the price quote.
- 4. An earnest money of Rs.100,000/- in the form of FDR on the name of the Director, IIT Kanpur having the validity period of six months should be attached in a separate envelope. No interest shall be paid on FDR.

- 5. Bidders those are registered with the Central Purchase Organization [i.e. DGS&D], National Small Industries Corporation or the concerned Ministry/Department are exempted from submitting the EMD. Proof of the same must be attached with the bid. Also, bidder must indicate the Registration No. on envelope cover.
- 6. The EMD will be forfeited, if the bidder withdraws or amends in tender or impairs or derogates from the tender in any respect within the period of validity of its tender.
- 7. The furniture should carry a minimum warranty period of one year on its workmanship, in normal use. The items that require replacement or repair due to defects in material or workmanship during the warranty period have to be repaired and/or replaced at no cost to the Institute.
- 8. Rejected items, if any, have to be removed and be replaced within 3 days and if needed penalty clause, if any, shall be imposed against the defaulter.
- 9. Penalty @ 1% per week or part thereof subject to a maximum of 10% of the price will be deducted from the balance payment, if supply is not completed within the stipulated period.
- 10. All the furniture will have to be delivered and put in appropriate place by 30th June, 2012. Hence, bidder incapable of completing the task within stipulated time is advised not to participate in the bid.
- 11. The decision of the committee shall be final and binding on all stake holders.
- 12. Bidder is requested to visit Halls of Residence No. 9 or 10 for the detailed view of samples, in case of any doubt.
