TENDER NOTICE

Dy. Registrar (S&P), on behalf of Director, IIT Kanpur invites sealed quotation for providing & fixing seating arrangement at New Lecture Halls.

a. Name & Nature of Works:

Providing and fixing seating arrangement at new lecture Hall complex 1 no. 600 capacity and 2 no. of 400 capacity. (Complete Detail as per Annexure-'A')

b. Submission & opening of tender:-

Sealed tenders shall be received at the office of Deputy Registrar, Central Stores, IIT Kanpur-208016 upto 02.06.2015 till 03:00 P.M. and tenders will be opened on the same day at 03:30 P.M.

c. Time period for completion of work:-

90 Days.

d. Validity:-

Tenders shall be valid for acceptance for 90 days from the last date of submission.

e. Security Deposit:-

10% security shall be deducted from the bills of the contractor. The 5% shall be released after 6 months on satisfactory performance of work and balance 5% after 12 months from the date of completion.

f. Performance Guarantee:-

The agency shall have to deposit the Performance Guarantee within 10 days from the issue of letter of intent either in shape of Bank Guarantee or in shape of FDR issued from any nationalized bank for the amount equal to 5% of the tendered value for timely completion of the job. The Performance Guarantee shall be released after the satisfactory completion within the stipulated period.

g. Penalty Clause:-

1% per week of the tender value of work shall be deducted if the work is not completed within the stipulated period. The maximum penalty shall be 5% of the tendered value.

h. Payment:

The running bills shall be paid at every 1/3 rd execution of work of the tendered value.

A handwritten signature in blue ink, appearing to be 'S.P.' or similar initials.

i. Qualification:-

The agency should submit the proof of having its own workshop with all necessary pipe bending machines etc required to complete the job.

j. Power Supply:-


The required power supply shall be provided on chargeable basis at one point. The present electricity charges are Rs. 8 per unit.

k. Quality of the material to be used:-

The MS pipe of ISI marked to be used in chairs and ISI marked commercial plywood shall be anti termite treated of Century/Duro or equivalent make only.

l. Supervision:

The work should be executed under the close monitoring of authorized representative of DOAA. The payments shall only be released after satisfactory execution certificate is obtained from the authorized representative of DOAA.

1. Bidder Qualification Requirement:-

A. The bidder should fulfill atleast one conditions from the below mentioned list:-

1. The bidder should have executed 1 no. of order of similar nature (similar nature means fabricated furniture supplied to any educational Institution) having minimum value of Rs.4320000=00.
2. The bidder should have executed 2 no. of orders of similar nature (similar nature means fabricated furniture supplied to any educational Institution) having minimum value of Rs.3240000=00.
3. The bidder should have executed 3 no. of orders of similar nature (similar nature means fabricated furniture supplied to any educational Institution) having minimum value of Rs.2160000=00.

B. The bidding company should be headed by technically qualified person or its project head for the proposed project should be technically qualified, having exposure to same kind of work.

2. The Employer-M/S IIT Kanpur, reserves the right to reject any or all the tenders and accept the lowest or any other tender or award the different parts of the tender by splitting them to different TENDERERS without assigning any reasons thereof.
3. Any work/part of the contract works shall not be sub-let to a third party without the prior written approval of the Employer/Architect. Only those sub-contractors shall be employed who are pre-approved by Employer/Architect.
4. No interest shall be payable on security deposits or any delayed payments, at any stage.
5. The cost/expenses incurred in preparing & submission of this tender shall be exclusively borne by the TENDERER only.
6. The TENDERER is advised to note that this is a prestigious project of the employer to be executed by them in accordance with the details given in the tender documents, in order to provide materials and workmanship of international standards.

10. All tenderer shall be required to return all technical details/description/specification of material/drawing etc. to the Architect/IIT Kanpur at the time of submission of tender.



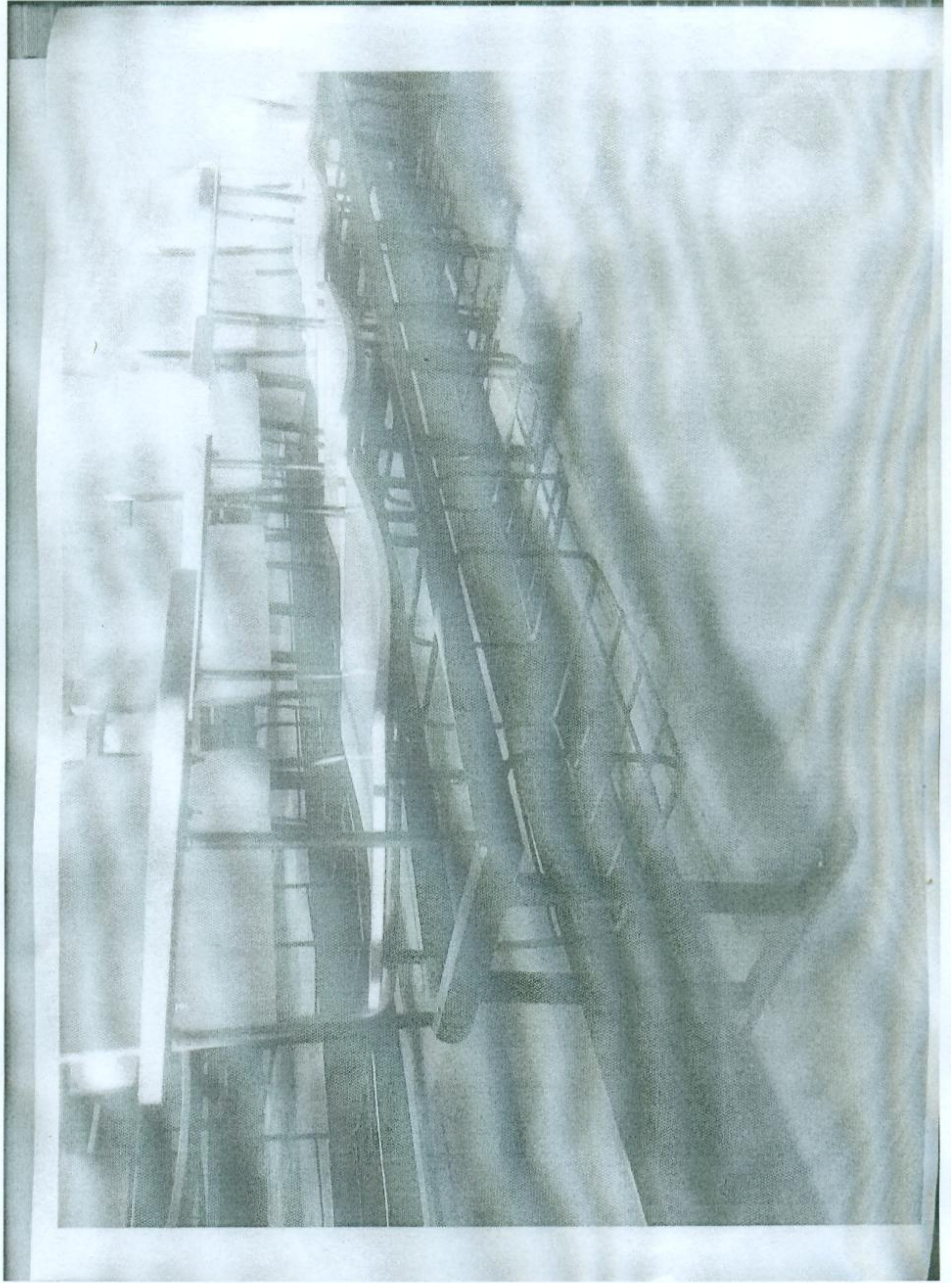

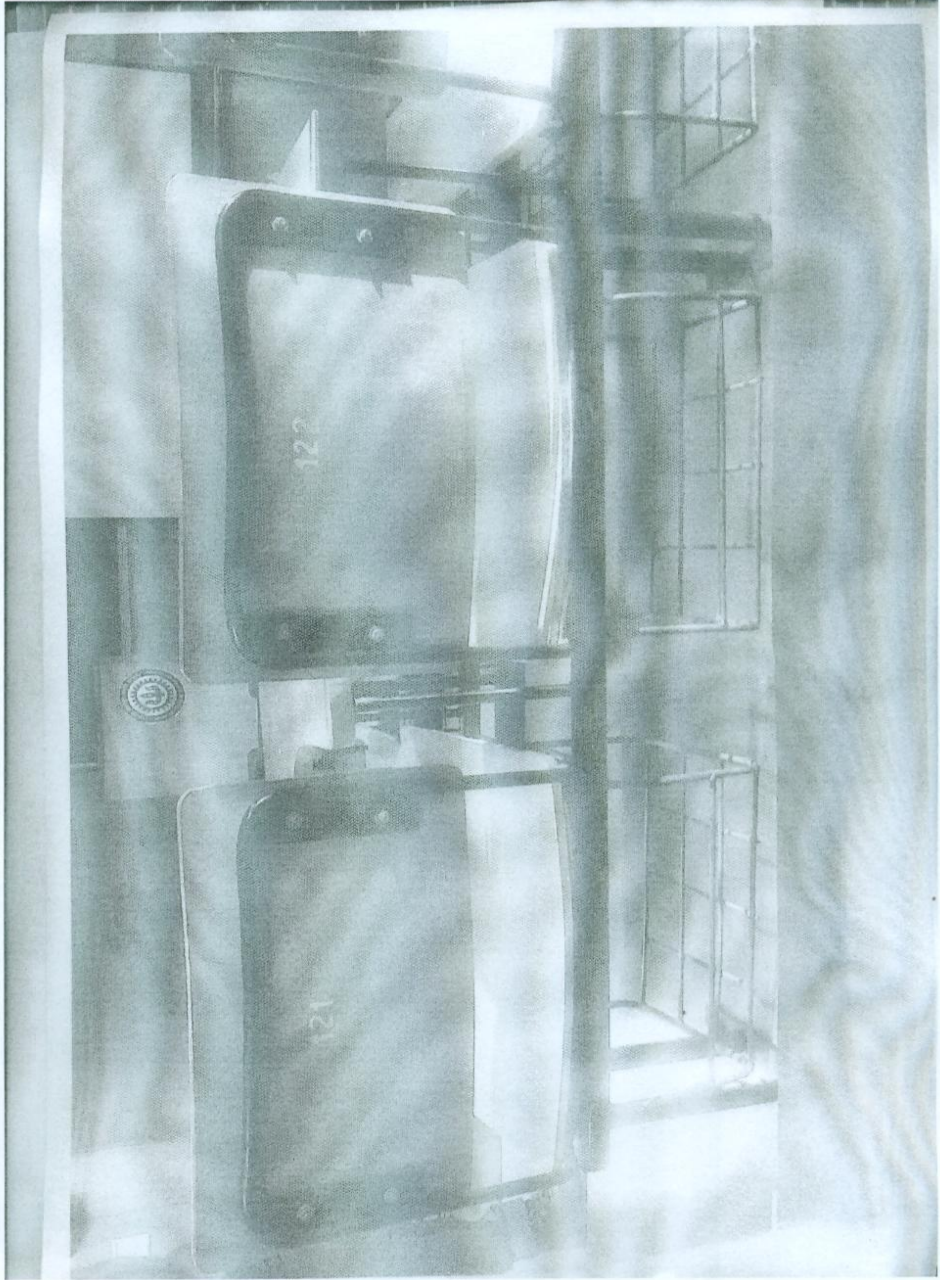

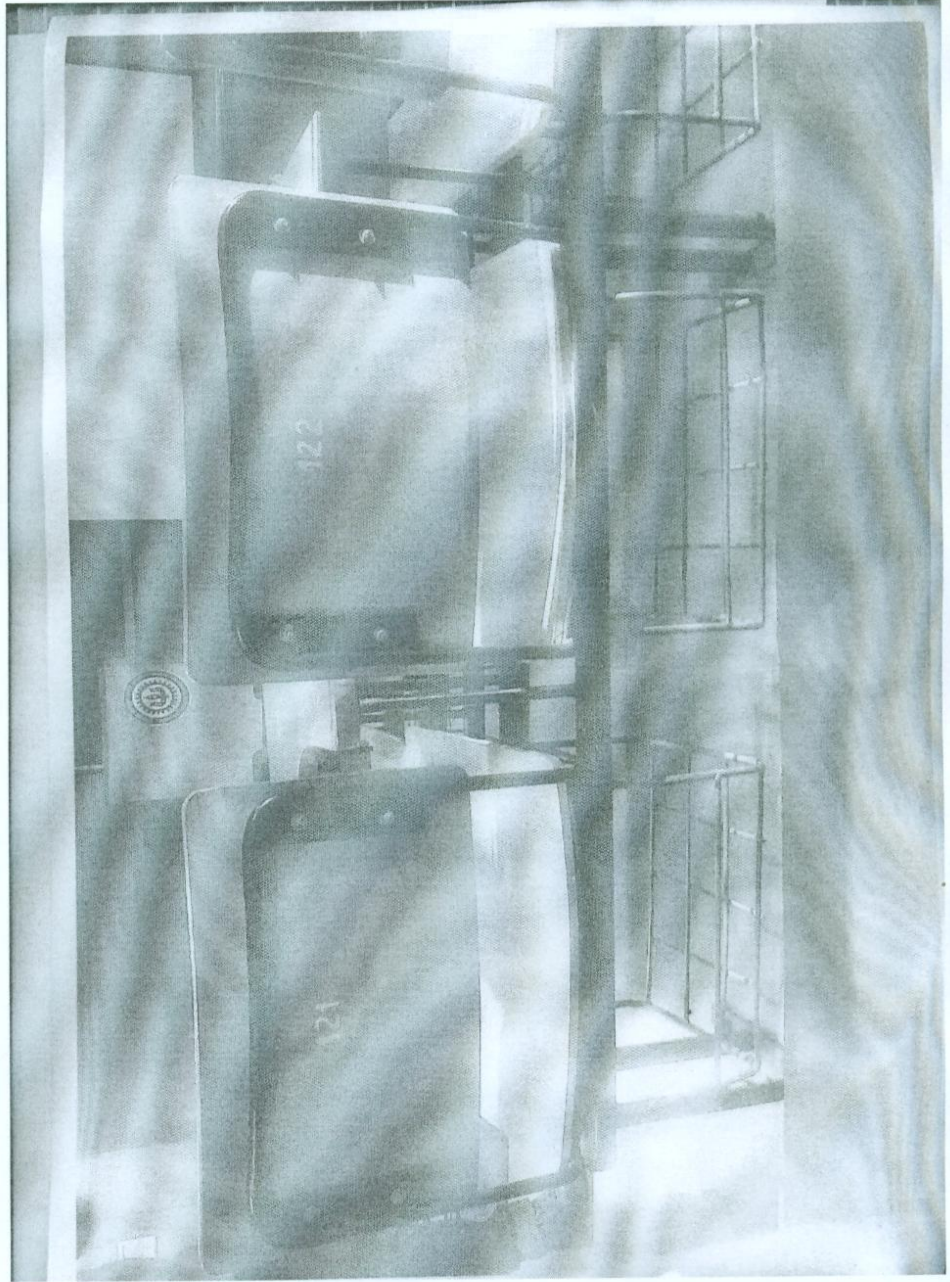
